### How to teach this activity

This activity tests learners' ability to conduct research, and apply their knowledge and skills about clubs, by presenting a project.

### Suggested answers

### Teacher guidance

- Divide learners into groups of 3.
- Use a period to fully explain requirements and rubric.
- Divide the workload of the topic and give each learner what is required of him/her.

## Required

Arrange to visit a local club in your area or find information about a club on the internet. You must collect relevant information from the club to prepare the following aspects:

- Introduction
  - » give a brief definition of non-profit organisation
  - » write a short synopsis of the club you visited (name of club, where situated and activities the club offers)
  - » attach a consent letter signed by the club's management confirming the your visit.
- Constitution of the Club. If you are able to obtain the constitution attach the contents at the end of the project. You are required to give a brief explanation of the following aspects:
  - » Vision and mission
  - » Objectives
  - » Colours
  - » Membership
  - » Affiliation
  - » General meetings
  - » Amendments of the constitution
- You must provide a detailed explanation of the following aspects
- » Entrance fees and membership fees: the amount, how it is collected, measures put in place for defaulters etc.
- » Office bearers and their roles and responsibilities
- » Finances: the accounting procedures, financial statements, internal control measures and audits
- Provide possible strategies to improve the image of the club.
